The enclosed notice is for **informational purposes only** and is required under certain government agencies. Enclosed is the following information:

- **Summary of Material Modifications (SMM)** – As required under Title I of ERISA and the DOL Regulations, this summary advises you of changes to the information contained in your Midwest Operating Engineers Retiree Welfare Plan Summary Plan Description (SPD). Please read this notice, keep this notice with your SPD, and if you have any questions, please contact the Fund Office. Important changes include the following:
  - **Enhancements in mammogram benefits coverage** – Effective September 1, 2016, the Plan will cover 3D mammogram screenings.
  - **Human Leukocyte Antigen (HLA) Testing Changes** – We are pleased to announce that effective April 1, 2017, the Plan will expand coverage of HLA testing to include up to two (2) non-immediate family members in very specific situations as noted in the SMM.
- **Notice Under Section 1557 of the Affordable Care Act** - The Department of Health and Human Services (HHS), through the Office of Civil Rights (OCR), recently issued comprehensive final regulations titled Nondiscrimination in Health Programs and Activities. The regulations implement Section 1557 of the Affordable Care Act (ACA) which prohibits exclusion from participation, denial of benefits or discrimination on the basis of race, color, national origin, sex, age or disability, in certain health care programs or activities.

**Summary of Material Modifications  
Midwest Operating Engineers Retiree Welfare Plan (RWP)**

June 14, 2017

**TO: All Eligible Retired Members**

This Summary of Material Modifications (SMM) advises you of changes to the information contained in your Midwest Operating Engineers Retiree Welfare Plan Summary Plan Description (SPD). Please read this notice, keep this notice with your SPD, and if you have any questions, please contact the Fund Office.

The following change will be effective September 1, 2016:

**Enhancements in Mammogram Benefits Coverage**

Due to medical practice changes and other developments, 3D mammograms are becoming much more common. As a result, the Board of Trustees has decided to expand coverage to include 3D mammogram screenings.

We are pleased to announce that effective September 1, 2016, the Plan will cover 3D diagnostic mammograms and mammogram screenings. The Plan currently covers traditional 2D diagnostic mammograms and mammogram screenings. Both 3D and 2D mammogram screenings, are payable at 100%, up to the routine maximum of \$350.00. Diagnostic mammograms are subject to the Retiree Plan deductible and co-insurance.

Coverage for mammograms will include both 2D and 3D diagnostic mammograms and mammogram screenings.

The Plan will expand coverage to include 3D mammogram screenings as preventive service, payable at 100%, up to the routine maximum of \$350.00. 3D diagnostic mammograms will be subject to the Retiree Plan deductible and co-insurance.

The following change is effective April 1, 2017:

**Human Leukocyte Antigen (HLA) Testing Change**

We are pleased to announce that effective April 1, 2017, the Plan will expand coverage of HLA testing to include up to two (2) non-immediate family members in very specific situations.

HLA testing is done to match organ and tissue transplant recipients with compatible donors. The transplant benefit covers certain donor-related expenses, if those costs are not covered under another plan. Coverage for donor searches, including HLA testing, has been provided, but only for parents and siblings of the transplant recipient. Participants will continue to have the option to obtain HLA typing of immediate family members (i.e. parents and siblings) to determine a transplant match.

However, the Plan will now allow Participants to obtain HLA typing for two non-immediate family members in any of the following three (3) very specific situations:

1. The Participant has no immediate family members who are alive and are a donor match;

2. The Participant has no immediate family members who are a donor match and can serve as a donor without causing harm to himself; or
3. The Participant has made documented attempts to obtain a donor match from an immediate family member and no immediate family member is willing to participate.

HLA testing of non-immediate family members is limited to two (2) non-immediate family members per transplant recipient.
